

**Raybestos '32 Roadster Pick-Up Sweepstakes
OFFICIAL RULES**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. ELIGIBILITY:** The Raybestos Ford Roadster Sweepstakes ("Sweepstakes") is open to individual legal residents of the 50 states of the United States and the District of Columbia who are 18 years of age or older. Employees of Affinia Group, Inc. ("Sponsor") and its affiliated companies, and the immediate family members of each such employee (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in the same household as each such employee are not eligible to enter or win. Participation in this Sweepstakes and acceptance of a prize may be restricted by your employer's policies regarding participation in trade promotions; you should check with your employer before entering or accepting a prize.
- 2. HOW TO ENTER:** The Sweepstakes begins on June 15, 2010 and ends on September 15, 2010 (the "Sweepstakes Period"). There are four methods of entry into the Sweepstakes.

Entry Method #1 (Authorized Installers): authorized Raybestos installers will receive an official entry form with the purchase of a Raybestos Ford Roadster Sweepstakes promotional kit, available through August 31, 2010. To enter, complete the official entry form and mail it to: Raybestos Ford Roadster Sweepstakes (Installers), 3459 Washington Drive, Suite 105 Eagan, Minnesota, 55122. OR, installers may enter the Sweepstakes without purchasing a promotional kit by legibly hand printing full name, employer's name and address, complete home address (no P.O. boxes please), date of birth, and daytime phone number on a 3" x 5" piece of paper and mailing the entry to the address above.

Entry Method #2 (Consumers): Consumers who purchase a qualifying Raybestos product from a participating installer during the Sweepstakes Period will receive an official offer form for a Raybestos/Hollywood Hot Rod T-shirt (size XL) (approximate retail value: \$12.00). To receive a free t-shirt, complete the official offer form and mail it to: Raybestos Ford Roadster Sweepstakes, 3459 Washington Drive, Suite 105 Eagan, Minnesota, 55122. Each consumer that submits a properly completed offer form will also receive one entry into the Sweepstakes. OR, consumers may enter the Sweepstakes without making a purchase by legibly hand printing full name, complete home address (no P.O. boxes please), date of birth, and daytime phone number on a 3" x 5" piece of paper and mailing the entry to the address above.

Entry Method #3 (Counterpersons): Counterpersons at authorized Raybestos dealers who sell at least 50 Raybestos products during the Sweepstakes Period will receive one (1) entry into the Sweepstakes by submitting a valid Reward Tally Card (provided with the installer promotional kit) to the address indicated on the Reward Tally Card.

Terms Applicable to All Methods of Entry by Mail: All entries/offer forms/Tally Cards must be postmarked by September 15, 2010 and received by September 20, 2010. Entries must be mailed in a hand-addressed envelope. No photocopies or mechanically reproduced entries allowed. Limit one (1) entry per postmarked envelope. Sponsor is not responsible for late, lost, misdirected, mutilated, incomplete, illegible, or postage-due entries or mail. Entries become the property of Sponsor and will not be returned.

Entry Method #4: During the Sweepstakes Period, enter online at www.raybestosgarage.com. **Limit one (1) online entry per person/email address.** Automated methods of entry are prohibited and any use of automated devices will cause disqualification. An email address is required for entry. Should multiple users of the same email account enter the Sweepstakes and a dispute thereafter arises regarding the identity of the entrant, the authorized account holder of said email account at the time of entry will be considered the entrant. "Authorized account holder" is defined as the natural person who is assigned an email address by an Internet access provider, on-line service provider or other

organization which is responsible for assigning email addresses or the domain associated with the submitted email address.

- 3. WINNER SELECTION/PRIZES:** A random drawing from all eligible entries received will be conducted on or about September 22, 2010 to award one (1) Grand Prize. Odds of winning depend on the number of eligible entries received. **ONE (1) GRAND PRIZE:** a Custom 1932 Ford Roadster Pick-up built by Troy Ladd of Hollywood Hot Rods. Approximate Retail Value ("ARV"): \$50,000. Vehicle will be officially transferred to winner at a media event during the Indianapolis 500 weekend, May 27 to May 29, 2011 and following this event Sponsor will make arrangements to have the vehicle delivered to winner's residence. **Winner must be a licensed driver and must present a current valid driver's license and proof of insurance prior to taking possession of vehicle.** Winner is solely responsible for all title, license, registration, insurance and other fees associated with taking possession and ownership of the automobile. A second random drawing will be held from all entries received from Installers (Entry Method #1) to award one (1) Installer Prize. Sponsor does not make, nor in any manner is responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to any prize, including but not limited to its quality, fitness for purpose or mechanical condition. Sponsor is not responsible for any errors in these Official Rules, Sweepstakes materials or the announcement of winners.
